# DONOR IMPACT ON A Lasting Legacy


One blustery, cold November day in 1874, six Sisters of Mercy came to Baltimore City Hospital, where they were charged with overseeing a small infirmary that would eventually grow to become Mercy Health Services.


Today, there are fewer members of the Sisters of Mercy to embody our living mission—yet still, the dedication to provide tender and personal care to the poor and underserved endures. Building upon the unique good will engendered by our upcoming 150th anniversary, we have launched The Sisters of Mercy Endowed Legacy Fund. Support from this

endowment will ensure our excellent medical care and abundant charitable services carry on for another I5O years.

As a community hospital focused on quality services for all, endowed funds will help us invest in cutting-edge technologies and state-of-the-art clinical spaces so we can offer the very best health care possible. Endowment gifts can support fellowships, scholarships, research projects, and medical conferences. It can also allow Mercy to retain award-winning doctors and nurses and world-renowned specialists embedded throughout our health system.

in workforce development: "Stella
Maris serves elders and people in
need of rehabilitation, long-term
care, and inpatient or home hospice
care. One of the ways we can offer
outstanding services is by providing

honoring the Sisters of Mercy could
help educate future caregivers about
evolving best practices."

Indeed, endowment is a stabilizing reserve of funding that broadens and deepens the services for everyone who depends on Mercy or Stella Maris for care.

"I made a gift to the Legacy Fund because I know endowment is all about longevity," says Marilynn Duker, Co-Chair of Brightview Senior Living and Vice Chair of the Mercy Health Services Board of Trustees. "Endowed funds let us care for the sick, the poor, and the dying—even during emergencies such as pandemics, natural disasters, or economic downturns—without having to diminish our services or reduce staff."

Kevin Pearson, Executive Vice President of M&T Bank, shares, "I donated to The Sisters of Mercy Endowed Legacy Fund because I know a struggling community is strengthened when people from all walks of life can access health care in a dignified way. My Legacy Fund gift can support endeavors such as comprehensive prenatal care and accredited CenteringPregnancy classes offered at Mercy's Mead Maternal Health and Preventive Care Center. The work being done at the Mead Center is part of Mercy's extensive efforts to address racial disparities in health, in keeping with its mission of compassionate care. I like the idea that the investment I make now will help Mercy make a difference in the future."

It also allows our institution to address patients' most pressing barriers to quality health care. As a Catholic health care system with a special commitment to the poor and vulnerable, each year Mercy provides at least \$22 million in charitable care for the disadvantaged.

"Having a strong endowment ensures that Mercy can continue to reach marginalized people," says Rick Berndt of the Mercy Health Services Board of Trustees. "When the Sisters of Mercy came to this

country, they came to serve the poor and needy. This is still their focus today. Endowment provides ongoing resources for exactly this purpose. I hope my donation inspires others to join me in supporting the Sisters' mission far into the future through gifts to The Sisters of Mercy Endowed Legacy Fund."

Patients' needs tend to evolve whether it is an elderly patient who can't afford assisted living facility entrance fees; a low-income patient who could heal faster if provided free prescriptions, medical supplies, or nutritious food; or a cancer patient who needs safe rides to and from their chemotherapy sessions. The donors who gave to The Sisters of Mercy Endowed Legacy Fund in Fiscal Year 2023 ensured that Mercy had the resources and flexibility to guarantee that the work and mission of the original six Sisters of Mercy is perpetuated under lay leadership.

## DONOR IMPACT ON Women's Health

Fiscal Year 2023 was the perfect time to reflect on the remarkable strides made in the 20 years since Mercy opened the Weinberg Center for Women's Health & Medicine.

Mercy has always been committed to Catherine McAuley's vision of caring for women in a way that empowers them to lead healthy, fulfilling lives. Our original Center for Women's Health & Medicine was created in 1994; then in 1995, the Center blossomed under the leadership of Dr. Neil B. Rosenshein—one of the nation's foremost gynecologic oncologists.

In 2003, a transformative gift from the Harry and Jeanette Weinberg Foundation, combined with other donations made to the Building on the Quality of Mercy capital campaign, allowed us to open a new building with more than II8,000 square feet dedicated to expanding our women's health programs.

Today, women comprise more than 64% of Mercy's patients; the Harry and Jeanette Weinberg Center for Women's Health & Medicine offers them multifaceted, interdisciplinary approaches to wellness. From reproductive health to preventive care to treatments for cancer, this world-class Center of Excellence helps women face unique health challenges that require specialized attention.

Many of our patients are so impressed by the outstanding clinical care offered at the Weinberg Center that they want the same experience for their mothers, grandmothers, sisters, and friends—and so we come to care for multiple generations within the same family. Private support has been essential in creating, expanding, and equipping many of the Weinberg Center's specialty centers to serve an increasing number of women.



### DONOR IMPACT ON Women's Health

For example, in 2008, the Tyanna Foundation raised funds in memory of Tyanna Barre O'Brien, who lost her battle with breast cancer. This foundation was established by her daughters, who continue to raise money in her memory all over the country. With their support, Mercy opened the Tyanna O'Brien Center for Women's Imaging at Mercy, where our highly trained radiologists use top-of-the-line imaging equipment to diagnose and treat breast-related diseases. Over the years, financial support from our grateful patients and Corporate Partners has helped this department keep up with technological advances by upgrading CT, MRI, and PET scans, as well as new ultrasounds. This way, Mercy can continue offering women one of the best diagnostic experiences in the state.

Should a woman receive a complicated diagnosis, she can be assured of the best of care at the Weinberg Center. For example, ovarian cancer is one of the most difficult cancers to diagnose and therefore hard to treat in time. Thanks to generous support from Donald Segal and Dr. Barbara McAlpine Segal in honor of Don's mother, Mercy opened the Lya Segall Ovarian Cancer Institute in 2014. Over the last decade, thousands of women from across the mid-Atlantic region have turned to the top-rated ovarian cancer doctors here for their compassionate care, diagnostic services, and high-quality surgical skills.

unrestricted philanthropy. We are deeply grateful to the donors who bring such state-of-the-art technologies to our community hospital. In a more recent example, a former patient of Dr. Neil B. Friedman, Medical Director of the Hoffberger Breast Center, was so pleased with her care that in Fiscal Year 2023 she made a donation toward the purchase of Spy-Phi equipment. A Spy-Phi allows surgeons to use near-infrared fluorescence to visualize microvessels in the breast for better accuracy during mastectomies and reconstruction procedures. It is the only equipment of its kind in the world, and our doctors are thrilled to be able to offer it to our

Unfortunately, not all women in our community have equal access to high-quality care, resources, or the latest health information. Socioeconomic disparities, cultural biases, and a limited network of personal support can act as barriers to women receiving the clinical care they deserve. Mercy's Charity Care programs help to address these inequities.

Our community stakeholders and philanthropic partners provide additional support. For example, the Tyanna Foundation's annual BreastFest event raises funds for things such as transportation to appointments, prosthetics, lymphedema garments, imaging services, and much more to benefit Mercy's breast cancer patients. The Mildred Mindell Cancer Foundation provides grant funds for free wigs and head coverings for women undergoing cancer treatment.

Indeed, over the past two decades since the Weinberg Center opened surgeries, women's imaging, plastic been at the forefront of promoting

During her six full terms as a board member, she also served as Chair of the Advisory Board for the Weinberg Center and was part of Mercy's Capital Campaign Planning Committee. Lois was a Trustee of the Hoffberger Foundation, now known as Hoffberger Family Philanthropies, which established The Hoffberger Breast Center at Mercy and has gifted Mercy with an endowment to support breast care for women without financial resources. The Mercy Family extends our heartfelt condolences to Lois' family. She was devoted to Mercy

and will be deeply missed. Her legacy will live on through the patients whose lives she touched at Mercy.



# donor impact on Community Safety

Last year, domestic abuse accounted for 21% of all violent crime across Baltimore City, according to the Baltimore Police Department. As a member of the medical community with an historic commitment to the welfare of the City, Mercy plays a significant role in interrupting cycles of abuse.

The health care setting offers a unique opportunity to intervene in abusive situations, as anecdotal evidence from experts shows that victims are more likely to request help from a medical professional than from domestic violence centers or law enforcement.

By employing an average of nine on-call Family Violence Response Program Advocates and more than 30 specially trained Forensic Nurse Examiners, Mercy can offer victims round-the-clock assistance. Our programs serve victims of sexual assault aged 13 and older. They also help survivors of domestic violence, abused and neglected elders, institutionalized vulnerable persons, and victims of human trafficking.

### DONOR IMPACT ON Community Safety

Mercy works collaboratively with community partners and criminal justice agencies to address victims' various and complex needs. Thanks to our generous funders, we are able to help more than 600 victims each year.

The Family Violence Response Program staff provide crisis intervention, advocacy, danger assessment, safety planning, and short-term follow-up. They also connect victims to community partners for shelter, legal services, and resources such as affordable mental health care, local support groups, and books or websites with useful information.

The Forensic Nurse Examiner Program is comprised of a skilled team who specialize in performing medical exams and treatments, and collecting and documenting crucial time-sensitive evidence of assault. The only comprehensive program of its kind, Mercy's forensic services include photographing and documenting wounds using Alternate Light Source technology, testing for STIs and pregnancy, and helping with affidavits for victims who wish to apply for legal asylum. The entire exam process is confidential and does not require that a victim report anything to the police, but evidence is stored for up to 75 years in case an investigation is desired.

"These programs provide victims with tools to achieve safety, wellness, and justice," says Lauren Brown, Coordinator of the Family Violence Response Program. "We are grateful to funders who make it possible for Mercy to offer these life-saving services."

Debra Holbrook, MSN, RN, SANE-A, FNE, A/P, DF-AFN, FAAN, is the Director of Forensic Nursing at Mercy. With more than 30 years of experience, Ms. Holbrook has pioneered the use of Alternate Light Source technology—which allows for the detection of bruises hidden under a victim's skin—in strangulation cases that set precedent in Maryland court systems.

"Thanks to a very generous grant, Mercy was able to pilot an Alternative Light Source program in the early 2000s that has since impacted tens of thousands of lives," Ms. Holbrook says. "The National Institute of Justice is currently conducting a research study into Mercy's forensic programming to help standardize the use of such evidence in criminal prosecutions nationwide."

A grantor also helped Mercy develop our Blue Dot program—named for the blue sticker any patient suspected of being trafficked received on their file. This alerted medical staff to the need for discreet intervention. The Blue Dot program was so successful that Mercy staff went on to host workshops on the topic for Baltimore City police, other medical facilities, local universities, the FBI, and Homeland Security.

Ms. Holbrook recalls a recent Blue Dot intervention that saved the life of a human trafficking victim:

"A young woman from South America was brought to Mercy's Emergency Department as a victim of extreme abuse. With the help of a bilingual team member, we discovered that this patient was being blackmailed and prostituted by an abuser who threatened the life of her toddler. Our staff spent

hours with the victim, explaining her rights. Grant funds helped purchase a disposable cell phone and 90-day data plan so she could connect with Catherine's Cottage for shelter and TurnAround, Inc. for therapy sessions. We also connected her with Asylee Women's Enterprises, Tahiri Justice Center, and Intercultural Counseling Connection for legal aid. Our staff thoroughly treated and then documented her injuries so that she could apply for an emergency T-Visa for herself and asylum for her son. Thankfully, both are now safe."

Mercy is proud to note that last year, Ms. Holbrook and her team received the prestigious Presidential Award for Extraordinary Efforts to Combat Trafficking in Persons. This outstanding achievement is a testament to their unwavering commitment to exceptional care and community safety.

"Whether Mercy is helping victims who live right down the street or people who are trafficked from very far away," Ms. Holbrook says, "the critical work we do to protect victims is made possible thanks to generous supporters who want to make the world safer."

# Hospice Care

Patricia Massey was a kind and vivacious woman. She loved to quilt and sew—she even made her own wedding dress. She married Joseph McNeely in May of 1985 and they adopted twin girls Katie and Maria in 1987.

An alto, Patricia sang with the Handel choir, the Pride of Baltimore Chorus, the Sweet Adelines, and the choir of St. Vincent de Paul Roman Catholic Church, where she was a member. Patricia also had been a board member of the Creative Alliance and served on the Baltimore School for the Arts' Capital Fundraising Committee.

A fierce advocate for the underserved, Patricia held several positions in the Baltimore Department of Housing & Community Development since the late 70s. In 1984, she helped then-Mayor William Donald Schaefer create the Baltimore Housing Partnership, where she served as Director for 10 years. She worked tirelessly on dozens of affordable housing projects in Baltimore City. Then, in her own company, Metroscape Development, she revitalized neighborhoods by building hundreds of affordable homes for ownership, becoming one of the very few early successful female developers in the state.

In 2014, while leaving her office one winter afternoon, she fell down a flight of stairs and suffered a severe traumatic brain injury. Patricia was taken to the hospital and remained in a coma for a few weeks. During the next 18 months, she was a patient at various Intensive Care Units, skilled nursing care facilities, and rehabilitation centers. In 2016, her family reconstructed their home to include hospital beds and mechanical lifts so as to be able to care for her there. Unfortunately, her health declined to the point where she needed constant professional care. After more stints of time in ICUs and skilled care facilities, space finally became available for her to come to

Stella Maris in March of 2020.

At Stella Maris, Patricia received excellent round-the-clock care from both Stella staff and private certified caregivers her family had hired. For nine months, her husband Joseph took an apartment at Mercy Ridge so as to stay close to her. His balcony faced Patricia's room.

"People were not able to visit in person due to the COVID-19 restrictions," Katie recalls, "but the staff helped us stay in contact with Mom. We used technology like FaceTime and an Amazon Echo device equipped with a camera so we could 'join' her for dinner. The staff at Stella even helped Mom make signs to wave at us through the windows."



Katie goes on to say: "It was such a stressful, uncertain time—but we never doubted my mom was in the best hands. Everyone at Stella, from the nurses to the administrative staff to the custodians, they all treat guests so well. We watched the way they treated my mom while she was getting end-of-life care. We came to trust them as if they were a part of our own family."

Patricia passed away in February of the following year. Instead of flowers, the family asked that donations to Stella Maris be made in her memory.

Katie shares, "We grieve the loss of Mom every day, but we also know she was a person who lived her whole life giving back to others. My family and I wanted to honor that in some way. We knew from first-hand experience that Stella's hospice services allow the dying to experience warmth, comfort, and dignity. So in addition to our family making donations, I also volunteer at the Stella Maris Crab Feast and the Wine Tasting fundraisers. Because I work at Loyola University Maryland as the Program Director for Advancement Events, I am glad to harness my skills to help other families in need of hospice services. I think Mom would have really loved that."

#### Corporate Partners Breakfast

Mercy hosted its annual Corporate Partners Recognition Breakfast on May 4, 2023, on its downtown campus. The breakfast recognizes businesses and organizations for their support of Mercy's programs and services. The breakfast featured a panel discussion moderated by Dr. David N. Maine, who posed questions regarding the state of healthcare to three of Mercy's top physician specialists: neurosurgeon Jon I. McIver, M.D., of The Center for Minimally Invasive Brain & Spine Surgery; Teresa P. Diaz-Montes, M.D., MPH, FACOG, associate director of The Lya Segall Ovarian Cancer Institute and medical director of The Neil B. Rosenshein, M.D., Institute for Gynecologic Care at Annapolis; and Lew C. Schon, M.D., FAAOS, director of orthopedic innovation at the Institute for Foot and Ankle Reconstruction.



#### Circle of Mercy Reception

Over 250 donors, volunteers, and friends attended Mercy Health Services' biennial Circle of Mercy Donor Recognition Reception at the Mt. Washington Mill Dye House in Baltimore on November 10, 2022. The event provided Mercy the opportunity to honor the many individuals, corporations, and foundations who have made significant contributions to programs and services at both Mercy and Stella Maris. Speakers included Dr. David N. Maine, Sister Helen Amos, RSM, and Marilynn Duker, Co-Chair of Brightview Senior Living and Vice Chair of the Mercy Health Services Board of Trustees.

The Circle of Mercy Donor Recognition Reception was preceded by a Corporate Partners President's Reception for Mercy's corporate donors, where Frank R. Palmer IV, former senior vice president with The Whiting-Turner Contracting Company, addressed attendees.

#### BreastFest

BreastFest, an annual "cocktails for a cause" fundraiser produced by Mercy's longstanding partner The Tyanna Foundation, was held in September 2022. The Tyanna Foundation works tirelessly to make breast cancer more comfortable for patients and less prevalent nationwide. Hundreds of enthusiastic walkers gathered at Eastern Regional Park in Middle River in September 2022 for the 13th Annual Heat It To Beat It benefit walk, a fundraiser to support research led by surgical oncologist Dr. Armando Sardi, Medical Director of the Institute for Cancer Care at Mercy. The increasingly popular and inspiring event raised \$220,514 to support ongoing cancer research.



#### Crab Feast 2022

In October, the 38th Annual Crab Feast and Hospice Day of Giving was held at the Timonium Fairgrounds to benefit Stella Maris. Guests enjoyed all-you-can-eat crabs, fun games, music, raffles, and auctions. The option to participate in a drive-thru pick-up was available for supporters who preferred to enjoy crabs from a safe social distance. More than 25 committee members, 50 volunteers, and 700 participants made the 2022 Feast one of the most successful to date, generating \$127,692 in support of hospice care.





#### Wine Tasting

In April 2023, Stella Maris celebrated its 70th anniversary with "A Toast to Stella Maris' 70th—A Very Special Tasting of Wine and Craft Spirits." Offered to over 400 guests at the Grand Lodge of Maryland, the event included a live and silent auction, and proved to be the most successful to date. The event raised \$118,206 to benefit long-term care services at Stella Maris.
